2. Contact your Municipal Clerk for number of signatures required or in alternate at least 10.
3. Petitioners must sign in their own handwriting, giving their printed name and residence address under the words "Signatures of Petitioners", in the presence of someone.
4. The person in whose presence the Petition was signed must sign the Petition and make the affidavit before an officer authorized by law to take affidavits.
5. The Candidate or Candidates must sign the Certificate of Acceptance, stating that he/she or they is or are qualified for the office and a member of the political party mentioned in the Petition.
6. The Candidate or Candidates must take the Oath of Allegiance before an officer authorized by law to administer oaths.
7. File the Petition with the Municipal Clerk not later than 4:00 p.m. 64 days prior to the date of the Primary Election.
