Approval of these taxes will result in a permanent increase in the District's tax levy.</p> <p>INTERPRETIVE STATEMENT</p> <p>Due to actions taken by the State of New Jersey in the Spring of 2010 to withhold previously anticipated and budgeted State Aid payments and to drastically reduce State Aid allocations for the 2010-2011 school year, in combination with the imposition of the two percent "tax levy caps" and the rising costs associated with educating the students of the Borough of Cape May Point, the District has incurred a permanent recurring shortfall in its annual budget. District fund balance is currently being applied in attempts to try to address this recurring shortfall.
