PUBLIC QUESTIONS TO BE VOTED UPON

PROPOSAL NO. 1

The Board of Education of the City of North Wildwood in the County of Cape May, New Jersey is authorized: (a) to undertake various improvements and the replacement of the heating, ventilation, and air conditioning systems and roof restoration at Margaret Mace Elementary School including related work, fixtures, and equipment; (b) to appropriate \$4,018,653 for such purposes; and (c) to issue bonds of the school district in the principal amount of \$4,018,653.

The final eligible costs of the projects approved by the Commissioner of Education are \$4,018,653. The proposed improvements include \$0 for school construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this election.

PROPOSAL NO. 2

(This Bond Proposal No. 2 will only go into effect if Bond Proposal No. 1 is also approved by the voters at this election.)

The Board of Education of the City of North Wildwood in the County of Cape May, New Jersey is authorized: (a) to undertake renovations, alterations and improvements at Margaret Mace Elementary School including related work, fixtures, furnishings, and equipment; (b) to appropriate \$931,250 for such purposes; and (c) to issue bonds of the school district in the principal amount of \$931,250.

The final eligible costs of the projects approved by the Commissioner of Education are \$931,250. The proposed improvements include \$0 for school construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this election.

INTERPRETIVE STATEMENT

If both bond proposals are approved by the voters at this election, the Board of Education will be authorized to undertake school capital projects for a total cost of \$4,949,903 and to issue bonds in the total principal amount of \$4,949,903 to fund the projects. The aggregate amount of the final eligible costs of the projects approved by the Commissioner of Education is \$4,949,903. The projects include \$0 for school construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects approved at this election.
